Tuition for all stand-alone courses:

Must be paid in full the day of the course. Example: If the stand-alone course tuition is \$350.00, a total of \$350.00 will be collected at the beginning of the first day of the course.

Tuition for Esthetics Program:

Northern Colorado Advanced Aesthetics Academy does not accept full payment in advance for any tuition. Kit Fee must be paid prior to the week of start date and is non refundable. Monthly Payments are accepted for these programs in equal monthly installments (full tuition of program divided by length of time given to complete program, Ex ample: full time 150 days divided by 30 days = 5 months.

Breakdown – Tuition of \$8,300.00 divided by 5 months = \$1660.00 per month. Students are allowed to pay a budget payment of a minimum of \$250.00 per month, with a balance due at the end of training. (Example: Full time 150 days divided by 30 days = 5 months. Breakdown budget payments of \$400.00 per month x 5 = \$2,000.00 with a \$6,300.00 balance due at end of training).

Tuition fees are due on the 20th day of the following month after student commences training. Payments not received by the 20th day of the Month due are subject to a \$50.00 late fee per day, and payments not received by the 30th of the month shall be released from the program, with refund/balance due (if any) as stated by the refund table provided.

Student Complaints

Attempting to resolve any issue with the school first is strongly encouraged. Refund Policy

Students not accepted to the school are entitled to all monies paid. Students who cancel this contract by notifying the school within three (3) business days are entitled to a full refund of all tuition and fees paid. Students who withdraw after three (3) business days, but before commencement of

classes, are entitled to a full refund of all tuition and fees paid except the maximum cancellation charge of \$150.00 or 25% of the contract price whichever is less. In the case of students withdrawing after commencement of classes, the school will retain a cancellation charge plus a percentage of tuition and fees, which is based on the percentage of contact hours attended as described in the table below. The refund is based on the official date of termination or withdrawal.

- 1. The student may cancel this contract at any time prior to midnight of the third business day after signing this contract.
- 2. All refunds will be made within 30 days from the date of termination. The official date of termination or withdrawal of a student shall be determined in the following manner"
 - a. The date on which the school receives notice of the student 's intention to discontinue the training program; or
 - b. The date on which the student violates published school policy, which provides for termination.
- c. Should a student fail to return from an excused leave of absence, the effective date of termination for a student on an extended leave of absence or a leave of absence is the earlier of the date the school determines the student is not returning or the day following the expected return date.

- 3. The student will receive a full refund of tuition and fees paid if the school discontinues a program/stand-alone course within a period of time a student could have reasonably completed it, except that this provision shall not apply in the event the school ceases operation.
- 4. The policy for granting credit for previous training shall not impact the refund policy.
